Seller agrees that Stokes Auction or Olympic Vintage Auto Club assumes no liability for loss or damage to the vehicle and seller agrees to hold the auction company, their agents and their employees harmless from any claims for bodily injury or property arising out of said auction sale. Seller should maintain insurance on their vehicle.
4. Unreserved cars must be declared "No Reserve" at time of consignment to receive "No Reserve" rates and commission.
5. Stokes Auction and / or the car club, Olympic Vintage Auto Club, reserve the right to refuse a vehicle for the auction.
6. Sellers must be present at auction and provide title to the vehicle if the sale is successful. (non-reserved turn title in prior to auction)
7. Limited covered vehicle space is available.
